1 On page 3, after line 17, insert the following:

2 "NEW SECTION. **Sec. 2.** This act is necessary for the immediate  
3 preservation of the public peace, health, or safety, or support of  
4 the state government and its existing public institutions, and takes  
5 effect immediately."

6 On page 3, line 19, after "insert" strike the remainder of the  
7 title and insert "reenacting and amending RCW 42.56.250; and  
8 declaring an emergency."

EFFECT: Adds an emergency clause.
